Membership dues are non-transferable, non-refundable, and are payable by January 1 of each year. All new members must pay a one-time \$50.00 application/initiation fee at the time they submit their membership application. All funds to PVA must be in U.S. dollars. Dues are subject to change. Your company must pay its dues before receiving a copy of your annual security certificate.

Contributions or gifts to PVA are not tax-deductible as ordinary and necessary business expenses. PVA will notify you annually of the non-deductible portion of your dues – the part that is allocable to lobbying.

Applicants must submit a photocopy of the Coast Guard Certificate of Inspection (COI) or other state approval authority papers for each vessel they operate before their application is processed.
